AN ORDINANCE TERMED THE ANNUAL APPROPRIATION BILL,  
APPROPRIATING CERTAIN SUMS OF MONEY DEEMED TO BE NEEDED TO DEFRAY  
THE NECESSARY CORPORATE EXPENSES AND LIABILITIES OF THE VILLAGE OF  
CULLOM, ILLINOIS, FOR THE FISCAL YEAR ENDING APRIL 30, 2017.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF CULLOM, ILLINOIS:





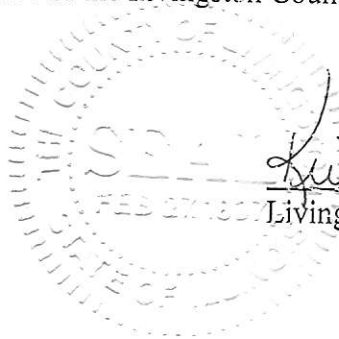
