Maintenance Report:

- Water usage for the month has returned to a seasonable normal
- The drop box for water payments has been ordered
- Lead testing is completed at 319 West Hack Street
- Grosso Trucking has been contacted to complete spray patching of streets
- A report on a new EPA requirement was presented to the board

Ordinance Committee:

A discussion was held pertaining to village violations that have been reported by village residents and board members. At least 48 violations were found. The Board decided to publish a public reminder to residents on the village website and Face Book in hopes that residents will take action on their own, before violation notices go out.

Lovell, in conjunction with Tri Point High School Honor Society students, will help residents who are unable to get their old electronic devices to the school for recycle on April 7.

T. Meister was asked to research other village's Building Zoning Ordinances and to report at the next board meeting.
