**ANNUAL LEVY ORDINANCE**

ORDINANCE NO. 2018-E

AN ORDINANCE LEVYING A TAX ON PROPERTY SUBJECT TO TAXATION WITHIN THE VILLAGE OF CULLOM, LIVINGSTON COUNTY, ILLINOIS, FOR THE CORPORATE PURPOSES FOR THE FISCAL YEAR ENDING APRIL 30, 2019.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CULLOM, ILLINOIS:

**SECTION 1**

That it is hereby ascertained by the President and Board of Trustees of the Village of Cullom, in the County of Livingston, State of Illinois, that the Board did on the 24<sup>th</sup> day of July, 2018 pass the Annual Appropriation Ordinance for the said Village of Cullom for the fiscal year ending April 30, 2019, which Annual Appropriation Ordinance, after its passage and approval, was duly published in the time and manner as prescribed by law and is now in full force and effect; and it is further ascertained that the total amount of said Appropriation appropriated for the purpose of defraying the necessary corporate expenses and liabilities for said Village for said fiscal year is in the sum of \$296,350.00, the purposes for which said appropriations have been made, the amounts appropriated for such purposes respectively, being in detail as follows:

## SECTION 2

Be it further ordained that a tax for the following sums of money be, and the same is, hereby levied for the Municipal purposes for the Village of Cullom, Illinois, for the fiscal year ending April 30, 2019, upon all properties subject to taxation within the Village of Cullom, Illinois, as the same are assessed and equalized for the State and County purposes for said fiscal year aforesaid to be collected by due process of law, and the amounts so received shall be applied to and among the subjects and purposes herein specified:

Section 3

The total amount of said Levy, to wit: Twenty-Eight Thousand Eight Hundred Thirty-Seven and 71/100th Dollars (\$28,837.71), is the same as the amount extended for tax purposes during the preceding year. There is, therefore, no requirement to have a public hearing pursuant to the provisions of the Truth in Taxation Laws.


Section 4

The Village Clerk of said Village of Cullom, Illinois shall at once file with the County Clerk of Livingston County, Illinois, a certified copy of this Ordinance to the end that the rate of percentum upon property assessed and equalized necessary to produce the total amount, to wit: Twenty-Eight Thousand Eight Hundred Thirty-Seven and 71/100th Dollars (\$28,837.71), shall be ascertained by the County Clerk and the above taxes shall be extended by him upon County tax records of Livingston County, Illinois, and hereafter collected in due time according to the revenue laws of the State of Illinois.

Section 5

This Ordinance shall be in full force and effect from and after its passage and approval.


