- Received an estimate from Tony Webster on park flooding problem and work on replacing sidewalk in front of the Frontier Building on Hack Street
- Ace-In-The-Hole has been contacted to fill in cracks and openings on Hack Street and will do the work when the weather permits
- Lovell attended a training session on upcoming restrictor guidelines from IEPA and on lead residuals in water systems
- Tri-Point made a visit to the Water Treatment Plant on May 20
