Employee Reports:

Spangler:

- Completed daily samples
- Completed Julie locations (one emergency)
- Assisted with pumping water manually while iron filter system is down.
- Assisted with coordinating installment of iron filter system.
- Assisted with a water leak at the corner of walnut and Jeffery. Water leak was located and it was the service line for 205 E Jeffery a foot off the tap from the main.
- Assisted with plans for new water line installation running from Jeffery and Hickory to the house on 3500.

DuVall:

- Trash rate increase takes eff 2/1 (Jan usage) going from \$16.69 to \$27.75
- Reviewed options for the internet. The only viable option at this time was to go with Mediacom and they installed internet on 1/20/25. (Frontier was only able to offer copper line at the location, which doesn't support the necessary upload speeds. Conxxus will not be available until sometime in Feb.) There is no annual contract so we would be able to explore other options down the road, such as Conxxus, if they wind up being a better value.
- The Maintenance building does not have internet currently, and Rodney is unable to get service on his phone inside the building due to the structure. Is this something we could look at? Possibly when Conxxus becomes available?
- New trash receptacle delivered to 406 E Jackson (old one had broken lid); New recycling receptacle ordered for 409 E Hack.
- ADT cameras installed 1/27 at the park to replace the old system. The remaining half of the installation fee was split into three payments of approx \$340 each.
- Meter installed at 409 E Hack St. Once Nicor is able to start service, water will be turned on.
- New residents at 409 E Hack, 202 W Jackson, 310 W Cleveland.
- Leaks (that I am aware of) were repaired at 316 E Cleveland and 205 E Jeffery
